NOTIFICATION

In exercise of the powers conferred by section 64 read with section 4 of the Indian Veterinary Council Act 1984 (Central Act 52 of 1984), the Government proposes to make the following amendments to the Karnataka Veterinary Council Rules, 1998- Rule No: 16,17,18,19,20 and 21

Now therefore, in exercise of power conferred by section 65 of the said act, The draft of Karnataka Veterinary Council (Amendment) Rules, 2020 is hereby published for the information of all persons likely to be effected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in the official Gazette.

Any objection or suggestion which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above, will be considered by the State Government. NOTIFICATION

In exercise of the powers conferred by sections 36,37,38,40,41,42,44,47,48,50,52 and 54 read with section 65 of the Indian Veterinary Council Act , 1984 (Central Act 52 of 1984), the Government of Karnataka hereby makes the following rules further to amend the Karnataka Veterinary Council Rules, 1998, namely:-

RULES

1. Title and commencement.- (1) These rules may be called the Karnataka Veterinary Council (Amendment) Rules, 2020.

(2) They shall come into force from the date of their publication in the official Gazette.

2. Substitution of rule 16.- In the Karnataka Veterinary Council Rules, 1998 (hereinafter referred to as the said rules), for rule 16, the following shall be substituted, namely:-

"16. voting.- (1) If the number of duly nominated candidates for election shall not exceed the number of members to be elected, the Returning officer shall forth with declare such candidates duly elected.

(2) If the number of such candidates exceed the number of members to be elected, the Returning Officer shall fix a period of not exceeding seven days for election of members through Online voting.

(3) For online voting, the eligible voter has to follow the following procedure, namely:-

- (i) he shall login with his registered number in the Karnataka veterinary practitioners register;
- (ii) after login he shall receive one time password (OTP) on his mobile number registered with State Veterinary Council;
- (iii) on entering such one time password the voter shall be able to see a list of contesting candidates and then he may vote by ticking as many candidates as there are seats to be filled by the election;
- (iv) after voting, voter shall get an acknowledgment that he has completed the voting process successfully; and
- (v) after voting, voter shall be automatically logged out and voting is not possible".

3. Omission of rule 17.- Rule 17 of the said rules, shall be omitted.

4. Omission of rule 18.- Rule 18 of the said rules, shall be omitted.

5. Substitution of rule 19.- For rule 19 of the said rules, the following shall be substituted, namely:-

"19. Counting of Votes.- (1) The returning officer shall, on the date and time fixed by him for this purpose enter the password and get the number of votes received by each contesting candidates.

(2) Any contesting candidate or his representative duly authorized in writing by him may remain present in person to watch the process of counting."

6. Substitution of rule 20.- For rule 20 of the said rules, the following shall be substituted, namely:-

"20. Declaration of results.- (1) The Returning Officer shall draw up a list of candidates in order of highest votes polled and declare the candidates elected, in that order according to the number of seats to be filled up.

(2) When there is equality of votes among any two or more candidates, the candidate who shall be deemed to have been elected shall be determined by lots to be drawn by the Returning Officer in such manner as he may decide.

(3) The Returning Officer shall, as soon as the result is declared, inform each successful candidate of being elected to the Council."

7. Substitution of rule 21.- For rule 21 of the said rules, the following shall be substituted, namely:-

"21. Retaining of Election documents:- After declaration of results, the Returning Officer shall preserve all the document relating to election for a period of six months and shall not destroy after this period without the previous concurrence of the State Government."
