## The general guidelines:

- 1) 75 veterinarians across States & UTs will be identified and nominated for Outstanding Veterinarians-2022, recognition.
- 2) The application is available on the VCI ("www.vci.dadf.gov.in') and the SVC websites.
- 3) Total of 60 nominations shall be made out of proposals to be received from state/ UT councils. Besides, 15 nominations shall be made by VCI from the proposals received directly at VCI.
- 4) The Veterinarians serving / residing in the state or UTs shall submit the duly completed application (in duplicate) to the Registrar, State / UT Veterinary Council. The name, address and contact details of Registrars of SVCs is provided. (annex- A)
- 5) The Veterinarians seeking nomination under VCI, may submit the application directly to O/o Secretary, VCI, 'A' Wing, 2nd Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
- 6) The minimum criteria for the Outstanding Veterinarian recognition will be as follows:
  - a) The aspirant Veterinarians should have valid registration in VCI / State Veterinary Council.

- b) Nominee may be either in service or retired from Government (State/ Central), Private, Autonomous, statutory body, board, NGOs, Self-employed or from any other field related to Veterinary Science.
- c) The contribution of veterinarians in the field of veterinary practice, teaching, research, extension, administration, social & political fields, art, culture, business, entrepreneurship or any other field relating to Veterinary science will be considered.
- d) The SVCS will forward all the applications to VCI for the final decision and nomination by this Council. The SVC shall retain one copy of the application for its records.
- e) The applications received by the VCI and through SVCs, will be scrutinized and finalized by the Council (VCI).
- f) The last date for submission of applications to VCI is 30<sup>th</sup> November, 2022. The applications received after the due date will be rejected.
- g) The Registrar State / UT Veterinary Councils are informed to ensure wide publicity through social media, newspaper, website, notice board etc. in the respective states for the information of veterinarians working at Universities, veterinary colleges, Dairy federation, Directorate (AH), ICAR Institutes, State and Central Government Institutes, NDDB, Industries, NGOs, private organization / self-employed etc.
- h) The process of nomination for Outstanding Veterinarians:2022 shall be in a fair and transparent manner and decision of the VCI will be final in all matters concerned.

The VCI requests the Registrar of all State/UT veterinary Councils to Co-operate and do the needful on priority. This decision of the Council to recognize the fellow veterinarians is an honor and is expected that it will pave ways for the motivation of the veterinarians and the next generations to come to the Noble field of Veterinary Science.
